

## Earth Changers Climate/Carbon Report 2021-22

**Total Measured Carbon dioxide equivalent: 2472kg CO<sub>2</sub>e = 2.4 tonnes.**

Our reporting period, start September 2021- end August 2022 continued to be affected by the pandemic. UK travel regulations were lifted mid-March 2022, enabling travel to some destinations though not all.

As expected on the base reporting year of 2020 global travel lock-down, our carbon impact increased: **279%**

This was largely due to a change in travel (mostly tube, taxi), due to once again being able to attend events, meetings and vital consultancy work, given ineligibility to government Covid business support, plus an energy reporting change (new smart meter) for greater control and accuracy.
